# Item 3: Minutes of Meeting of 18th May 2015

Minutes from the meeting of 18<sup>th</sup> May 2015 were put forward to the meeting for approval. Adoption of minutes was proposed by Miss C MacLennan and seconded by Mr G MacKinnon and duly signed.

## **Item 4: Matters Arising**

#### a) Web Page

Mr A Morrison advised that he is hopeful of having the issue resolved in early course.

Mr A Morrison advised that he has confirmed to Mrs A Munro of Struan Trust that all planning issues, having been resolved, could enable funds to be released and he will now proceed to order all required items so that the Flag Pole and seat can be in place for the Remembrance Service in November

## g) Cemetery Signs & Signs in the Community

Mr A Morrison advised that he has now received a response from Billy Nicolson at the Highland Council, Mr Nicolson advised that, if they have a Cemetery Sign in stock, they will arrange to have this erected. If not, will arrange to have one ordered and erected once received. In respect of the Struan sign that has been down for some time, Mr Nicolson advised that, as the sign belongs to the Community, they would be able to supply the fittings required to enable the Community to re-erect the sign. In respect of the Hill Road passing place signs they are hoping to do something with repairing and re-erecting these signs to assist with the smooth flow of traffic. Mr Nicolson advised that if they ever finish the patching programme they intend to do a bit on sign maintenance so as we have highlighted this particular road he will make sure this is high on the list. Mr Morrison will chase up Cemetery sign and find out what is required to re-erect the Struan sign.

## i) Adopt a Phone Box Scheme

Miss C MacLennan advised that she had commenced the Consultation process after contacting BT. Notices have now been lodged at each of the Phone Boxes at Struan and Shaggary to advise the public of the intention of the community to participate in the Adopt the Phone Box scheme. There is power to the Phone Box at Struan bit not at the Shaggary Phone Box. Miss Maclennan is to put a notice on the Notice Board with details of intention and will also speak to Cioch Direct to advise what is being proposed, as it would ultimately be the intention to move the defibrillator to the Struan Phone Box if all goes ahead. Miss Maclennan will keep CC advised as matters progress.

#### i) Battle of Festubert Commemoration

Mr B Morris and Mr K Davies attended the Civic Reception held by Highland Council on behalf of the CC; Mr Morris advised it was a very enjoyable and amiable evening and a credit to the Council. C MacLennan thanked Messrs Davies and Morris for representing the Community Council.

# d) Transport - Hospital
