1. Welcome and Apologies

With all Trustees present the meeting opened in the first instance by the Chairman, Mr John MacKinnon, who welcomed all to the first meeting of the New Year.

2. Minutes

Minutes from the meeting of 3rd November 2014 were put forward to the Trustees by the Secretary for approval. With minor amendments the Trustees agreed that they were a true representation of the meeting. Minutes proposed by Kenny Munro and seconded by Alastair MacPhie Minutes were duly signed. The Chairman also signed the minutes

3. Web Page Update

Mr Morrison had no further up-dates due to the holiday period. It was agreed that this should be given priority with the AGM being in June. Mr Morrison will take this forward.

4. Matter Arising

a) Deed of Trust

Mr Morrison is awaiting the original copy of the Trust Deeds from **MacLeod and MacCullum** to enable solicitors, **Ferguson MacSween & Stewart** to carry out the changes to the Deeds.

Ferguson MacSween & Stewart will draw up an endorsement to be agreed and signed by the Trustees which can be incorporated into the original document.

The secretary said that she may hold said Deed on file and will check and inform Mr Morrison

b) Outstanding Funding

Mr Morris reported that application 54 from **Struan Community Council** was still outstanding but all others have now been paid other than ongoing applications

c) Ambulance Support Vehicle

Mr MacPhie reported that the Support Vehicle was now on order and will be a Vauxhall Corsa Van. The vehicle was due to be delivered within the next two months, in the interim, **The Scottish Ambulance Service** will provide a van until the new one has been delivered.

5. Treasurer's Report

Mr Morris tabled the bank statements. Mr Morris reported the balance £105,697.60 included interest on the account of around £11. Ongoing funds approved but not yet accessed are A MacPhie Ambulance Support Vehicle £8750 Struan Community Council Flag Pole £500 Struan Jetty £7000 total £16,250 plus future payment per annum to NWSRA (North West Skye Recreational Association) of £5000

7. Approved Funding Reports

8. AOCB

a) SLCVO (Skye & Lochalsh Council for Voluntary Organisations

Mr MacKinnon tabled an Invoice for £15 for the Trusts Membership to SLCVO he had received from the former Chairman Mr D Beaton.

The Invoice was for reference only as it is paid by Standing Order. Mr Morris took it for his accounts.

b) Community App (Tablet or Iphone Application)

Mr MacPhie and Mr MacKinnon had attended a meeting with Dunvegan Community Council regarding the possibility of the Trust funding a community App which would be for walks in and around the area.

The cost for the set up would be £6000 with running costs of £500 a year which would be self funding.

Mr MacKinnon advised that they should contact Struan Community Council and that he would bring this up at the meeting. It was decided that Mr MacKinnon should contact their secretary Miss Maressa Munro to this effect.

c) Mr Munro wished to ask, in light of the application from **Dion Skye** App 56 in which no specified amount was on the application, should all applications specify an amount in section 5.

This was discussed and it was agreed that an amendment to the Guidance notes accompanying application forms should be made in section 5 stating that, **an amount must be specified in the application.** Mrs Munro will amend the guidance notes.
