Item 1: Welcome

Item 3: Minutes of Meeting of 9th May 2016

a) Defibrillator Training

Item 7 - Grounds Maintenance

Mr A Morrison tabled Maps that had been received from Mr W MacKinnon, Ward Manager, with details of the Grass Cutting that was being carried our CC Area, these being the Struan Old and New Cemeteries, Burial Ground at St John's Chapel and the Green at Struan, requesting that we consider if the cutting can be reduced or if local funding is available to undertake the works, the matter to be discussed at the next Ward Forum Meeting that Miss C MacLennan is hoping to attend. After discussion it was agreed that all require to continue to be maintained, in addition, as the works are the responsibility of the Council Trust Funding would; not be available due to the Deed of Trust precluding funding anything that is the responsibility of the Local Authority.

Mr J MacKinnon contacted Mr A Morrison within the past week to advsie that the second of the Struan Signs has now been blown down, Mr MacKinnon has moved the sign up to the Garage at present and will store in the Garage. Therefore, as both signs have now been blown down and are damaged it was agreed that the best way forward would be to obtain new signs as opposed to repairing the existing signs, also it will give the opportunity to up grade the signs with the facilities I the Community, these being Food, B&B, PO, Broch, War Memorial, Viewpoints, etc. Mr A Morrison to contact Mr D MacLeod at Highland Council to obtain quote for new Signs and that an application be submitted to Trust for funding.
