# 1. Welcome and Apologies

With all Trustees present the meeting opened in the first instance by the Chairman, Mr John MacKinnon, who welcomed all to the meeting.

### 2. Minutes

Minutes from the meeting of 26<sup>th</sup> January 2016 were put forward to the Trustees by the Secretary for approval. The Trustees agreed that they were a true representation of the meeting. ### 3. Matters Arising

The secretary was asked if she had received any updates from Cuillin FM (App 63 30<sup>th</sup>June 2015) Mrs Munro had not received any but said she will contact them and report back at the next meeting.

### 4. Treasurers Report

Mr Morris reported that at 31<sup>st</sup> March 2016 the Year End figures in the Trusts account was £100,074.19

Year End 2015 figure £ 93, 692, 74,

£30,000 of the Vattenfall payment was granted with a balance of £7000 from last year's monies. All monies are up to date.

The future payment per annum to NWSRA (North West Skye Recreational Association) of £5000 as not as yet been applied for

Mr Morris also reported that he has still not received an account from the Accountant for his services.

At the meeting on 26<sup>th</sup> October 2015 Mr Morris had proposed that the Secretary should receive an increase in her remuneration of £100 a year as she had not claimed any expenses for stationery etc. It was agreed in principle at that meeting providing that the **Deed of Trust** did not state that this would have to be put forward at an **AGM** (Annual General Meeting) Mr Morris had checked the Deed and no clause was in them to this effect. All Trustees agreed the increase which brings payments to the secretary to **£600** a year which is made up of two payments of **£300**, one in **March** and the other in **September**.
