John MacKinnon (Chairman) opened the meeting with a welcome to all.

#### 1. MINUTES

The minutes of the last AGM held on 20th June 2016 were agreed to being a true representation of the meeting were proposed by Geoff Semler, and seconded by Susan MacKinnon and were duly signed.

2. CHAIRMAN'S REPORT. Mr MacKinnon read out his report. See copy attached.

The balance in the Current Account at **31<sup>st</sup> March 2017** was **£126037.45** which at this date (June 26<sup>th</sup> 2017) is increased by **£39,127.00** Community Fund Payment for 1st July 2016-30<sup>th</sup> June 2017 giving a total balance of **£165,164.45** 

Mr Morrison reiterated what Mr MacKinnon had said to the meeting encouraging members of the community to come forward with projects or ideas for the community and said that it is unfortunate

that the Trust has more money this year than last and urged people to come forward with ideas and applications

Mr Morris invited questions from the floor.

**Mrs Peggy Semler** asked if there had been any applications received for this quarter year; Mrs Munro replied that she has only received one application for funding so far.

No other questions were raised.

There being no objections the accounts were ratified and signed by Mrs Peggy Semler and Mr Donald Beaton.

### Struan Community Trust Chairmans Report June 2017

The Trustees held a meeting directly after the 2016 AGM and granted funding towards building works to be carried out at the Skye Target Club amounting to £450.

Struan Primary School Parent Council were awarded £325 towards the purchase of a Picnic bench.

In the Autumn Cook Start Skye were awarded £447 towards cooking courses, unfortunately this did not take place so funding was withdrawn.

The Wee Blether Group application for £2000 was successful as was the Community Council application for £1038 towards the annual fireworks display.

Susan Mackinnon was awarded £99 to renew the Lights for the Community Christmas tree in the village.

Duirinish Youth Club received £1918 towards funding a Youth Leader.

At our last meeting the Gala Committee were awarded £1523 towards funding this years event.

The Community Council received £300 for the grass cutting around the benches and picnic tables around the village.

Finally one application was returned as we were unable to fund what they had applied for, we require them to re assess their application and re submit it with the relevant information. At the end of last year I met with Joanne Hutchinson who is a senior communications advisor with Vattenfall, she has taken over from Emily Faull as our new contact with the company.

As you know Brian moved away from the area earlier this year which means we have lost an excellent treasurer, as you would expect the books were done up to date before his departure, impeccably so as usual! On behalf of the Trust members I would like to take this opportunity to Thank Brian for his many years of service as treasurer for the Trust.

I would also like to thank Alison for all the work she has done again this year, her time and effort given to the Trust is invaluable and very much appreciated. John MacKinnon - Chairman
