Mr Morrison explained to members of the public present that the CC was fed by a yearly grant from **The Highland Council**, which has reduced over the years, it has now reduced from £710.96 in 2017 to £291.55 in 2018, Mr Morrison then proceeded to give a concise briefing of the Income & Expenditure Account, Mr Morrison explained that the closing balance in the Bank Account in the sum of £41,951.50 includes the sum of £1,740.00 for Bus Trips and £39,842.00 for the Play Park.
