#### 1. MINUTES

#### 3. TREASURER'S REPORT

Mr MacKinnon further advised that the next annual Community Fund Payment is due to be paid by Vattenfall imminent.

#### 4. APPOINTMENT OF TRUSTEES

Mr MacKinnon handed the meeting over to the secretary, Alison Munro. Mrs Munro stated that three Trustees were obliged to stand down this year – Mr Kenny Munro, Mr Alexander MacPhie & Mr Alasdair Morrison.

Three completed nomination forms were received. Mr Kenny Munro, Mr Alexander MacPhie & Mr Alasdair Morrison.

No objections were raised by the meeting to the three nominees being members of the Board of Trustees.

#### 5. Amendment to Trust Deed

The meeting was advised that at present 3 Trust Members have to stand down each year. Mr MacKinnon put forward a motion that this should be amended to only 2 members standing down each year, this was discussed and the meeting unanimously agreed for the amendment, this was proposed by Geoff Semler & seconded by Julia Rudram

#### 6. AOCB

There was a question regarding the Quorum required for an AGM to be held. This will be put onto the Agenda for the next AGM in 2020
