# Project Information

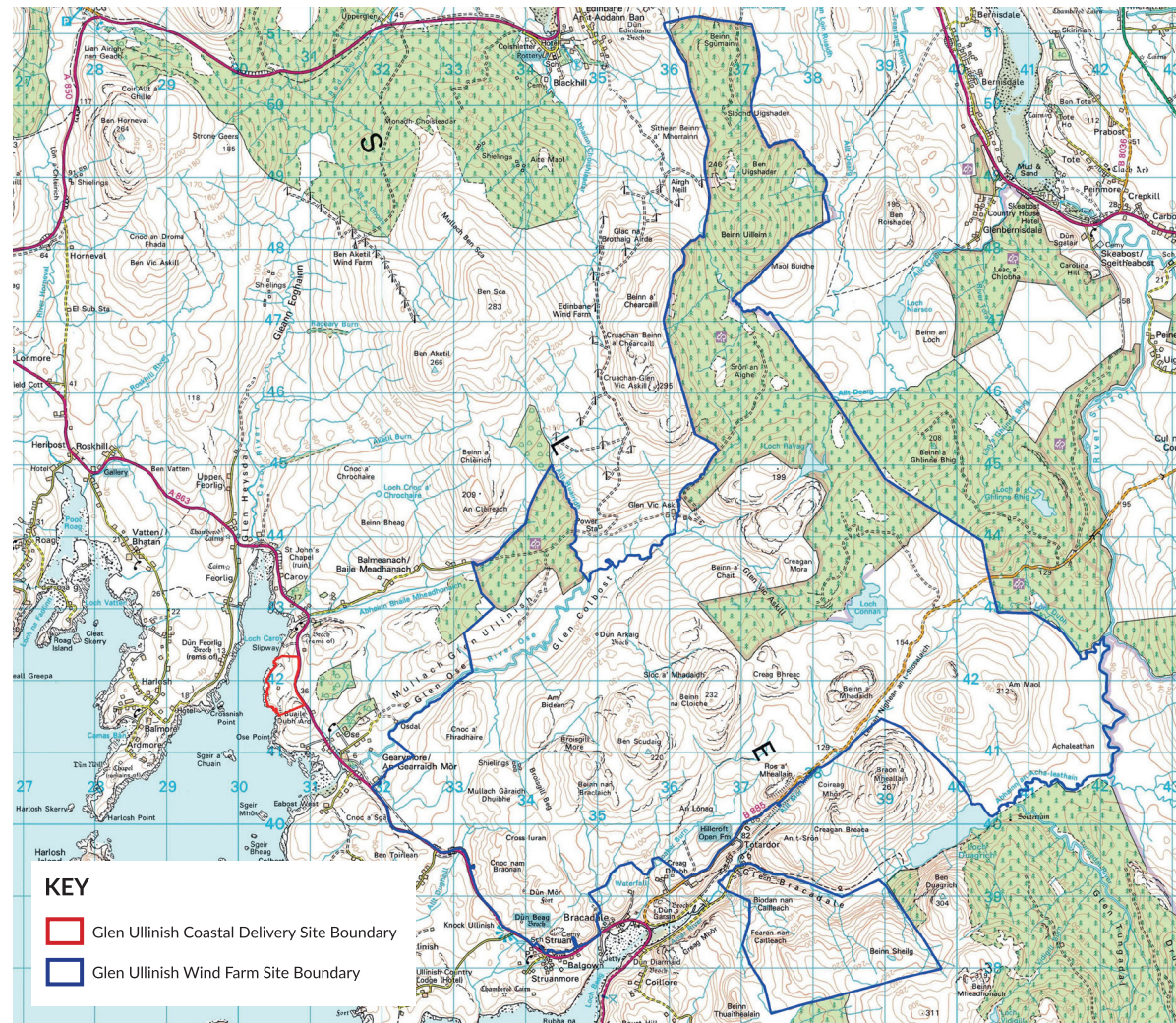
Muirhall Energy has submitted an EIA Scoping Report to The Highland Council and Marine Scotland to support a planning application and marine licence submission, expected in Autumn 2024. Further information on the project, and upcoming public consultations is provided within this leaflet.

Muirhall Energy currently has planning permission for 11 wind turbines with maximum tip heights of 149.9m (3 turbines have tip heights of 145m) at the site known as Glen Ullinish Wind Farm. The site is 1,800m south-east of Balmeanach, Struan, in the north-west of Skye.

Muirhall Energy has since looked at optimising the land at Glen Ullinish, and on 31st July 2023, submitted an application for a wind farm comprising 47 turbines at 200m to tip, known as Glen Ullinish II Wind Farm. If consented, this project would replace Glen Ullinish Wind Farm.

As part of the application, it is proposed to deliver turbine components from Kyle Harbour along the A87, before turning onto the A863 at Sligachan towards the site entrance. Whilst this delivery option is feasible, and the current application will be assessed as such, Muirhall Energy has considered public feedback and investigated other, less disruptive means, of delivering turbine components to the site.

Following various feasibility assessments and surveys, the eastern shore of Loch Caroy was identified as a preferred option for the construction of a new quay facility to receive wind turbine components. This will reduce the distance and time components are on Skye's road network from 40 miles to just over 2 miles, alleviating the impact on the wider road network.

The project is expected to consist of works above and below the Mean High Spring Tide, requiring both a planning application (for works above) and marine licence (for works or activities below). The quay will likely be formed through land reclamation. It may also involve some dredging or rock removal from the seabed, depending on the final location selected. A laydown area will be formed to allow for the temporary storage of turbine components, and an access track formed to the public road. Further details are provided in the Scoping Report and will be presented as part of the consultation events.

If consented, the project will facilitate the delivery of wind turbine components to construct Glen Ullinish Wind Farm or Glen Ullinish II Wind Farm (if consented). It is proposed that the quay would be a permanent structure for the duration of the wind farm, facilitating both construction and decommissioning. Muirhall Energy is also engaged with other developers in the area to discuss whether the quay could also service the delivery requirements of other proposed wind farms. As part of the consultation events, feedback on other prospective uses from the community would also be welcomed.
