Proposal of Application Notice: Glen Ullinish Coastal Delivery, Loch Caroy, North West Skye

We are writing to inform you that Muirhall Energy Limited (Muirhall Energy) has submitted a Proposal of Application Notice (PAN) to The Highland Council (the Council) which sets out the intention to submit a Major Planning Application for the creation of a new quay facility on the eastern shoreline of Loch Caroy, north west Skye. Enclosed with this letter is a copy of the PAN Boundary and PAN Form for your reference.

The intended use of the proposed quay is to service the construction of wind farm development in the area and alleviate the impact on the wider local road network. While the Proposal is specifically linked to the construction of either Glen Ullinish Wind Farm or Glen Ullinish II Wind Farm (if consented), the quay will be well positioned to serve other proposed new wind farms or repowering in the area.

The Proposal will also be subject to Marine Licence(s) for parts of the development below the mean high water spring tide level under the Marine (Scotland) Act 2010. An Environmental Impact Assessment Report will be required to accompany the Planning Application and Marine Licence(s), as the Proposal is a 'Schedule 1' development in terms of Section 8(2) of Schedule 1 of both the Marine Works (Environmental Impact Assessment) (Scotland) 2017 and the Town and Country Planning (Environmental Impact Assessment) (Scotland) 2017.

A request for a Scoping Opinion will be submitted to the Council and Marine Scotland in the coming weeks. A copy of the Scoping Report will be made available at <https://www.muirhallenergy.co.uk/> in addition to the Council's Planning Portal. Muirhall Energy intends to write to interested parties following the submission of the Scoping Report to identify how information can be accessed, share details of forthcoming consultation events and how feedback can be provided.

As part of the Major Planning Application, a minimum of two public consultation events should be held. Muirhall Energy intends to hold its first round of events as follows:
